**IN RE: AMENDED MAGISTRATE JUDGE
PAIRING ASSIGNMENT PLAN FOR

The Magistrate Judge Pairing Assignment Plan in the Southern District of Florida as set forth in Administrative Orders 2017-29, 2017-18, and 2014-64, is hereby amended.

It is further

ORDERED that recusals from Miami Magistrate Judges will be assigned to Magistrate Judge Turnoff; and recusals by Magistrate Judge Turnoff will be assigned to Magistrate Judge McAliley. It is further

ORDERED that Magistrate Judge Garber may be assigned CJA, Budget Matters, Attorneys' Fees, Settlement Conferences, Guilty Pleas, Motions to Suppress and Supervised Release Violations Hearings from all District Judges. It is further

ORDERED that this amended Magistrate Judge Pairing Assignment Plan is effective as to new cases filed on or after August 1, 2017, and as to cases filed prior to this date, wherein no previous matters have been referred. All open cases referred prior to August 1, 2017, shall remain with the currently paired Magistrate Judge until conclusion of the case. The presiding Judge retains discretion with respect to cases closed prior to August 1, 2017, as well as cases received via recusal, to continue reference to the originally paired Magistrate Judge where substantial judicial effort has been expended and such continued pairing would promote judicial economy. It is further

ORDERED that from the signing of this Order until August 1, 2017, Magistrate Judge Shaniek Maynard shall be assigned those cases that would have been assigned to Magistrate Judge Frank J. Lynch, Jr. under the current Magistrate Judge Pairing Plan, and all cases currently assigned to Magistrate Judge Frank J. Lynch, Jr., shall be reassigned to Magistrate Judge Shaniek Maynard effective as of the signing of this Order.

This Magistrate Judge Pairing Plan shall remain in effect until further ordered.
